

T-3311 Integral Thermostat and Piston Top Valve Actuator Dual Temperature, Dual Pressure

The T-3311 is a combination pneumatic thermostat and valve actuator that provides proportional control of a steam or water valve in a heating-cooling installation. This compact unit will fit most Johnson Controls normally open, normally closed, or mixing valves, sizes 1/2 through 2 inch NPT. It is designed primarily for use in a valve controlled terminal air conditioning unit.




Figure 1: T-3311 Integral Thermostat and Piston Top Actuator

Features

Thermostat

The T-3311 has a liquid filled bulb temperature sensing element and external setpoint adjustment for space control based on return air temperature. The T-3311 is non-relay type controller requiring dual supply air pressures of 15 and 20 psig (105 and 140 kPa). The controller has two built-in restrictors in the switch stack assembly, eliminating the need for an external restrictor.

Changeover from heating to cooling is accomplished by switching the supply air pressure. Both setpoints on the controller may be calibrated individually for identical setpoints or for two different setpoints; turning the dial changes both setpoints by the same amount. The thermostat mechanism is protected by a snap-on cover.

A dial marked "Cool-Warm" and a pointer are located on the cover of the T-3311.

The pointer has tabs that permit restricting the temperature adjustment range to as little as $\pm 2.5^{\circ}F (\pm 1.4^{\circ}C)$. It is factory set for a nominal adjustment of $\pm 7.5^{\circ}F (\pm 4^{\circ}C)$.

Linear expansion and contraction of the liquid in the element permits uniform dial graduations and provides a high degree of accuracy over the entire range of operation.

Actuator


Rapid and accurate response to the demands of the integral thermostat is assured by the actuator of the T-3311. The design provides a constant effective diaphragm area throughout the entire stroke. The diaphragm will remain resilient through years of service.

nterchangeability

The T-3311 is a direct replacement for the T-3310. The T-3311 has been modified to be compatible with VG7000 Series valves.

Note: While the T-3311 is 100% backward compatible for T-3310 replacements, the T-3310 cannot be used on VG7000 Valves.






Figure 3: T-275-100 Bulb Element Holder Dimensions, in./mm
