#### **Product Overview**

The AGXE Series is a rugged metal wall mount enclosure for GWNxx and GWNPxx gas platforms. The AGXE provides a modular solution for applications that require a rugged enclosure along with an integral audible horn and 10 A relay for direct fan control.

The AGxE is ideal for applications such as parking garage ventilation control and ensuring OSHA air quality compliance in mechanical rooms, commercial buildings, factories, vehicle bays and sally ports for ambulance, police, fire, taxi, etc.




Follow local and national building codes for installation.

To provide adequate protection, a circuit breaker rated 8 A or less, or a switch, must be provided and within easy reach of the AGxE enclosure. The circuit breaker or switch must be marked as the disconnection device for the AGxE.

To clean the enclosure, use a cloth to remove dust. Do not spray with liquids.

- 1. Swing the lid of the AGxE enclosure downward to the open position.
- 2. Place the AGxE enclosure on the mounting location and mark mounting screw locations.
- 3. Apply screws, leaving approximately 1/8" (3 mm) between screw head and mounting surface.
- 4. Using keyhole slots, hang the AGxE enclosure on the mounting surface. Tighten screws.
- 5. Remove the plastic front cover of the GWN Series gas platform device to expose the gas detection sensor. Retain the cover, as it contains DIP switch settings for your reference. DIP switch settings are also included in the installation guides for the GWN and GWNP gas sensors.
- 6. Align the GWN sensor and push it into the two matching connectors on the AGxE enclosure.
- 7. Plug the unused 3/4" (19 mm) hole with the provided plug.
- 8. Attach wires to the terminal blocks as described in the Wiring section.
- 9. Close lid and secure with the supplied screws.


#### Installing the GWN Series Gas Platform Device in the AGxE Enclosure






#### AGxE Enclosure with GWN Series Gas Platform Device Installed



#### **AGAE Wiring Connections** (GWNMxx, GWNVxx, GWN1xx)




#### AGPE Wiring Connections (GWNPxx)
